Repair-Only Station License: An Important Part of Smog Check Restructure

New license is expected in fall 2012



The Bureau of Automotive Repair (BAR) has been working to restructure the types of licenses offered to businesses and individuals currently employed in or seeking to work in the Smog Check industry. The goal of this effort is to align license types and requirements with industry and marketplace needs.

One part of this restructure involves the establishment of a Repair-Only station license. This license presents more options for stations to provide Smog Check-related repairs, particularly those stations that specialize in repairing certain types of vehicles. In order to obtain a Repair-Only license, the shop will need to employ at least one licensed Smog Check repair technician and meet certain equipment requirements.

Secure STAR Certification Through Proper Inspections

Editor's Note: This is one of a series of articles designed to assist Smog Check stations in the transition to the STAR Program. STAR is a new certification program for both Smog Check Test-Only and Test-and-Repair stations that wish to inspect directed and gross-polluting vehicles. STAR is scheduled for implementation in January 2013 and will supersede the Gold Shield certification program.



In order to join STAR, Smog Check stations must meet a minimum performance score. To attain this score, stations need to perform proper inspections as outlined in the Smog Check

Inspection Procedures Manual and as prompted by the BAR-97 Emissions Inspection System (EIS) software. Two common inspection errors that will affect a station's STAR score when performing an Acceleration Simulation Mode (ASM) inspection are vehicle over-conditioning and improper gear selection.

Proper Pre-Conditioning

A common inspection error by technicians performing an ASM test is over-conditioning. To avoid this situation, the vehicle should be in an idle, warm condition at the start of the first ASM test mode. If the vehicle is not sufficiently warm, the technician should let the vehicle idle for a few minutes to bring the coolant temperature up to its normal operating condition. Alternatively, the technician or consumer could drive the vehicle for a few minutes until it is fully warm. All vehicles subject to an ASM inspection must idle for at least three minutes immediately prior to the start of the first ASM test mode. Under normal conditions, this would occur naturally when entering vehicle data into the EIS.

Proper Gear Selection

A second common error when performing an ASM inspection is improper gear selection. The technician should make sure to place the vehicle in the correct gear prior to beginning an ASM test. For vehicles equipped with an automatic transmission, the correct gear is always "Drive." For vehicles equipped with a manual

transmission, the correct gear is always second gear unless the engine Rate Per Minute (RPM) falls outside of the allowable window displayed by the EIS. In such cases, the technician may select another gear to bring the RPM to within the acceptable range. The Bureau of Automotive Repair has a standard established each quarter that compares the rate at which technicians test vehicles in the wrong gear to tests by other technicians of similar vehicles statewide.

Smog Check Technicians

An individual may obtain the Smog Check repair technician license if they meet any one of the following four minimum requirements:

1. Possess certification in the categories of Electrical/Electronic Systems (A6), Engine Performance (A8) and Advanced Engine Performance Specialist (L1) from the National Institute for Automotive Service Excellence, and pass the state licensing examination. (This option is tailored for the most experienced technicians.) or
2. Possess an Associate of Arts or Associate of Science degree or higher in Automotive Technology from a state accredited or recognized college, public school, or trade school, and have one year of automotive repair experience in the engine performance area, and pass the state licensing examination or
3. Possess a certificate in automotive technology from a state accredited or recognized college, public school, or trade school with a minimum of 720 hours of course work that includes at least 280 hours in the engine performance area, and have one year of automotive repair experience in the engine performance area, and pass the state licensing examination or
4. Have a minimum of two years of automotive repair experience in the engine performance area, successfully complete BAR-specified diagnostic and repair training (formerly known as "BAR alternative training") within the last five years, and pass the state licensing examination.

Station Equipment Requirements

Repair-Only stations will be required to have engine diagnostic equipment and repair tools for ignition systems, fuel systems, emission control systems, computer engine control systems, and other related components for each type of vehicle that the station diagnoses and repairs. This may include a BAR-97 Emissions Inspection System or a "five-gas" analyzer to validate the repairs made to the vehicle will result in a smog certificate. Generally, Repair-Only stations will be required to have the same repair equipment currently required for Test-and-Repair stations.

A few exceptions to the equipment requirement will be granted. For example, stations that specialize in the repair of diesel-powered vehicles will not be required to have equipment needed for the repair of gasoline-powered vehicles, including an ignition analyzer, tachometer/dwell meter or a propane enrichment kit. As with existing Test-

and-Repair stations, before accepting a vehicle for repair, Repair-Only stations will need to assess whether they have the necessary expertise and equipment to properly repair a vehicle that has failed a Smog Check inspection.

At a minimum, equipment requirements for Repair-Only stations will include:

1. An ignition analyzer or ignition oscilloscope with the minimum capabilities;
2. A compression tester;
3. A tachometer/dwell meter;
4. A fuel pressure gauge capable of measuring the higher pressures of fuel-injected vehicles;
5. A propane enrichment kit;
6. An ammeter capable of measuring amps and milliamps;
7. A high impedance digital volt/ohmmeter;
8. Tools necessary to adjust, maintain, and repair vehicular ignition, fuel delivery, and emission control systems;
9. Diagnostic and repair information for all vehicles being tested and repair;
10. The most currently available Bureau manuals;
11. Automotive computer diagnostic and repair manuals;
12. Electronic component location manuals;
13. A device capable of retrieving trouble codes from vehicles with on-board computers. The device shall be On-Board Diagnostic II compliant, and shall have enhanced diagnostic test functionality;
14. An electronic device capable of graphically displaying any electrical or electronic signal used by an automotive computer system; and
15. A tire pressure gauge capable of accurately measuring tire pressure.

When to Apply

The Repair-Only license is scheduled to become effective on August 1, 2012. An application is expected to be made available in May 2012.

BAR Sting Operation Leads to Arrests, Citations in Stockton

Arrests underscore BAR's efforts to halt unlicensed businesses

A sting operation conducted by the Bureau of Automotive Repair (BAR) and the San Joaquin County District Attorney's Office resulted in the arrest of 10 individuals for providing automotive repair services without a license in Stockton.

"Consumers really expose themselves to risks when they go to an unlicensed automotive repair shop," said BAR Chief Sherry Mehl. "These individuals also harm businesses that play by the rules. That's why BAR has stepped up its efforts to work with local law enforcement offices to identify and arrest individuals engaging in automotive repair business without a license."

The operation targeted unregistered individuals who advertised automotive repair services on the Internet. BAR representatives responded to the online ads and made appointments with these individuals at a private home to repair an undercover automobile that the Bureau prepared for the sting. The individuals

claimed they could perform a variety of services, including windshield repair and brake jobs.

At the appointment, BAR representatives checked each individual's business license. Unlicensed individuals were then cited for violating the law and advised that the matter would be referred to the San Joaquin County District Attorney's Office for possible prosecution.

The 10 individuals taken into custody were cited for operating without a license and then released. They will appear in court and could face fines of up to \$1,000 and up to six months in jail.

Most businesses and professionals do a good job of providing services that benefit consumers and complying with the law," said the BAR Field Operations and Enforcement Division Deputy Chief Kristin Triepke. "These actions are a vivid example of why it is important for consumers to make certain they are doing business only with licensed repair facilities." **B:R**

Improve Your Compliance With the Law: Request An Education First Presentation

Presentations offered to new and existing licensees

Want to make sure that you and your staff understand relevant automotive repair laws and regulations? Then an Education First presentation may be for you.

So what exactly is Education First?

Education First is a free service offered by the Bureau of Automotive Repair (BAR) to new and existing licensees. It consists of a presentation to the owner, manager and employees by a BAR representative on relevant laws, regulations, policies, and procedures.

Besides an overview of automotive repair-related laws and proper estimate and invoice procedures, the BAR representative will also discuss certain aspects of BAR's operations and the services it provides licensees and consumers. In the course of the presentation, participants have an opportunity to ask questions and share their concerns and observations. Each presentation lasts approximately two hours and can be scheduled around the needs of your business.

"BAR's mission is to protect consumers in the automotive repair marketplace," said Kristin Triepke, Deputy Chief of BAR's Enforcement and Field Operations Division. "Education First goes a long way toward helping registrants understand those laws, as well as BAR's policies and procedures," she notes.

Education First is automatically offered to new registrants. However, any registrant can request a presentation regardless of how long they have been in business.

Triepke adds, "BAR is here to help, and Education First serves as an important tool to educate shops. The presentations emphasize ways to promote better business practices and a better understanding of the law."

BAR Takes Action Against Clean-Plugging

The Bureau of Automotive Repair (BAR) has been ramping up enforcement efforts against individuals suspected of engaging in “clean-plugging.” Clean-plugging consists of using a vehicle’s properly functioning On-Board Diagnostic (OBDII) system to illegally issue a smog certificate to another vehicle that will not pass an OBDII test on its own or is not present for testing. BAR views this practice as identical to “clean-piping,” where the tailpipe emissions measurement is obtained from a vehicle other than the one being certified.

BAR Field Operations and Enforcement Division has successfully argued its case against licensees engaging in this practice in court. The cases, in some instances, have additionally resulted in station and technician license revocations. District attorneys, acting on BAR’s investigations, have secured criminal convictions.

The courts have consistently ruled that stations and technicians engaging in clean-plugging pose a significant threat to the public and should be subjected to a level of discipline consistent with such conduct.

BAR Chief Sherry Mehl said “BAR is aggressively pursuing allegations of clean plugging.” She adds, “BAR is sending a clear message to those who engage in such unlawful business practices — you will be caught and prosecuted.”

Some stations and technicians whose licenses were revoked as a result of clean-plugging include:

- > **Smog Zone of Delhi** had its Automotive Repair Dealer (ARD) registration permanently invalidated, the Smog Check station license revoked, and the Advanced Emission Specialist technician license of owner Jaime Arroyo revoked (March 2011).
- > **Smog King Test Only** in Fairfield and Vacaville, and the Advanced Emission Specialist technician licenses of Rene Tinoco Servin, Khalad Jarada, and owner Ashraf Mohammad Isbeih were revoked (June 2011).
- > **1 Accurate Smog Test Only** of San Jose had its registration, Smog Check station license, and the Advanced Emission Specialist technician licenses of Julius Lee Phan and owner Mario Mateos-Montoya revoked (July 2011).
- > **Smog Zone Test Only** of San Francisco had its ARD and Smog Check station license revoked and the Advanced Emission Specialist technician license of owner Cahit Bingol revoked (July 2011).

- > **Ortega Test Only** of Los Angeles had its ARD permanently invalidated, the Smog Check station license revoked, and the Advanced Emission Specialist technician licenses of owners Jesse Ortega and Guadalupe Ortega revoked (August 2011).
- > **Monterey Test Only** of Monterey had its ARD permanently invalidated. The Smog Check station license and the Advanced Emission Specialist technician license of owner Tan Minh Tran were revoked (September 2011).

“BAR’s tough but fair approach to enforcement will continue under my watch,” said BAR Deputy Enforcement Chief Kristin Triepke. “If you suspect a station is engaged in illegal practices I encourage you to contact your local BAR field office,” she adds.

How to Avoid License Application Processing Delays

Complete applications are key to timely processing

Want to help make sure that your application for licensure with the Bureau of Automotive Repair (BAR) is processed in a timely manner?

Here's a tip: Before applying for licensure, make sure that the application contains all of the required information. If any information is missing, processing of the application will be delayed.



One of the most common omissions in applications submitted to BAR is failure to include the required permit and license numbers (i.e., seller's permit number or spray booth permit number). Although these permits take time to obtain, a licensing application should not be submitted to BAR without this information. If your business is exempt from any of the requirements, write "EXEMPT" in the appropriate space. Blank spaces on an application will result in a deficiency letter from BAR's Licensing Unit.

CAP Application Goes Online Soon

Electronic applications will benefit consumers and stations

The Bureau of Automotive Repair (BAR) will soon be offering consumers the ease and convenience of an online application for the Consumer Assistance Program (CAP). Development of the online application was based on licensee and consumer input.

Through this online tool, consumers will be able to submit an application, obtain a confirmation receipt, and check the status of their application at any time using a unique identification number assigned to them.

This change should substantially improve application processing time by CAP staff.

The online application will be available to everyone, regardless of whether they are seeking to repair or retire a vehicle and whether they must submit income-eligibility documents.

"Since participation in CAP has nearly doubled in the last year, this advancement will make it quick and effortless for consumers to apply for assistance through CAP," said CAP manager Tonya Blood. "It will virtually eliminate the need for consumers to mail in an application or stand in long lines at BAR field offices," she added.

BAR anticipates that the online application will become public in 2012. Stations will also be notified of its availability. **B:R**

A message from the California Air Resources Board

Catalytic Converter Lookup Tool Now Available

An important part of performing a Smog Check inspection is to check that all required catalytic converters are present and appear to be properly installed. To aid technicians in this portion of the inspection process, the California Air Resources Board (ARB), with assistance from aftermarket manufacturers, has developed a database on aftermarket catalytic converters that have been approved for use in California. These catalytic converters comply with ARB regulations that became effective on January 1, 2009.

The database includes all aftermarket converters that comply with ARB regulations adopted on January 1, 2009. It is also continuously updated to include catalytic converters recently approved by ARB. Eventually, the database will include catalytic converters for non-OBD II vehicles.

The database allows technicians to search for aftermarket catalytic converters by vehicle make, model and year, or by Executive Order (EO) number. The new database is only

applicable to passenger cars, light-duty trucks, and medium-duty vehicles.

Protect Yourself And Your Customers: Properly Secure Electronic Data

Increasingly, businesses are storing customer information electronically. This practice can expose a business to the theft of their customers' personal information.

- > Set a password to log into the computer on start-up and after it has been idle for several minutes. This will ensure that unauthorized people cannot gain access to your computer when you step away.
- > Protect your password by not attaching it to your screen and use a password that is hard for others to guess.
- > Never open an e-mail attachment from someone you don't know. This will help keep viruses from infecting your computer. It will also help prevent your computer from running slowly or allow others to obtain confidential data.
- > Keep your computer safe from hackers by installing security software and keeping it up-to-date. This will greatly reduce the risk of Internet hackers gaining access to your data.

The cost of implementing these measures are minimal compared to the risks your business could face. While nothing can completely protect you, following these steps will go a long way in keeping your information safe. **B:R**

Smog Check Station Equipment Audits

The Bureau of Automotive Repair (BAR) performs periodic audits of Smog Check station equipment. BAR primarily focuses on BAR-97 analyzers and related components, such as calibration gases, Low-Pressure Fuel Evaporative Tester, gas cap tester, sample hoses, and tamper detection systems.

Audit Findings

Between January and August 2011, BAR performed 5,145 audits. Deficiencies were found at 3,220 stations. In 580 instances, the audit finding was minor and fixed on-the-spot by a station representative. However, 2,640 findings were more serious and had to be corrected before any Smog Check inspections could be performed. The most serious findings led to an action by BAR's Field Operations and Enforcement Division.

Improve Your Chances of Passing An Audit

Here are some tips to help you pass an audit:

- > If service is required, only authorized manufacturer service representatives may perform repairs.
- > Only use BAR-certified parts, including hoses, probes and filters.
- > Never access or disable the secured areas of the analyzers.
- > Perform all required calibrations. **B:R**

Green Station Recognition Program



The Green Station Recognition Program, which is administered by the California Department of Toxic Substances Control (DTSC), is specifically designed for automotive repair shops regulated by the Bureau of Automotive Repair. In order to qualify, these

stations have pollution prevention measures that eliminate or reduce exposure to hazardous chemicals and potential

ground pollution. The eligibility requirements are outlined on the DTSC Web site.

Due to DTSC requirements, Smog Check Test-Only stations do not qualify to participate in the program because they neither handle nor dispose of hazardous materials typically found in repair shops.
